# Drug and alcohol

Drug and alcohol screening can improve workplace safety and helps to identify employees at risk of harmful lifestyle choices.

We offer an extensive drug and alcohol testing menu that includes a wide range of testing methods. Our comprehensive drug and alcohol testing services includes:

- Pre-employment drug and alcohol screening
- Random drug and alcohol screening
- For-cause/suspicion drug and alcohol screening
- Post-incident drug and alcohol screening

NRL offers a variety of drug testing options which include urine, hair and blood.

NRL provides testing to detect a wide range of drugs and their metabolites with specimen validity testing (adulterants), including:

- Amphetamine
- Barbiturate
- Benzodiazepine
- Cannabinoid
- Cocaine
- Methadone
- Phencyclidine
- Tramadol
- Buprenorphine
- Opiate
- MDMA/XTC
- Spice/K2

The specimen validity testing includes testing for the following adulterants: Creatinine, Nitrite, Glutaraldehyde, pH, Specific Gravity and Oxidants.

## Drug testing methods

### Laboratory based screening test

Laboratory results are sent to the employers within 24-48 hours. If needed, NRL can provide on-site sample collection services

### Point of Care (POCT) screening test

For employers that require rapid drug test results, NRL offers onsite drug testing services done by experienced and trained sample collectors with results available minutes after sample collection

### Confirmatory drug test

For the confirmatory testing of positive and non-negative results from drug screening tests. Confirmatory drug test results are typically released in 7 to 10 calendar days.

## Chain of custody procedure

NRL follows rigorous International Standards of Chain of Custody procedures, documenting the handling and storage of specimens from the moment a donor provides the specimen, right to reporting of the final test result, maintaining control and accountability of samples.

NRL's chain of custody procedure ensures strict discipline is observed and implemented throughout and requires authorized signatures at each step. This enables NRL to monitor possession, maintain integrity and prevent tampering with the sample or results.






## COVID-19 PCR testing

We can provide corporate testing packages for COVID-19 on both a regular and ad-hoc basis.

Our laboratories in Abu Dhabi and Dubai operate 24/7 and have a daily testing capacity of 7500+ samples, enabling us to support large volume collections.
